The above animal has not, to my knowledge, been in contact with Equidae showing clinical signs of African horse sickness, Dourine, Glanders, Equine encephalomyelitis, Equine infectious anemia, Vesicular stomatitis, Rabies, Anthrax Borna disease, Contagious equine metritis, Equine viral arteritis, Epizootic lymphangitis, Hendra virus infection or Surra during the 90 days prior to the date of this declaration.

For at least 30 days prior to the date of this declaration the above animal has not come into direct contact with other Equidae that are either diseased or Equidae that come from a country of a lesser health standard as the animal certified in this declaration.
